- 1. Chris Called the meeting to Order at 5:02. , Introductions took place. Attendance: PBPG: Chris Olson, Marcia Nordstrom, Paula Gandolfo, and Ed Gallagher. Community: Don Gross, Kevin Szepe, Kathy Watson, Ronnie Ames and Ambrose Wong
- 2. Non-Agenda Public Comments (Note: 2 minutes maximum per speaker) Issues not on Agenda and within the jurisdiction of PBPG Streets and Sidewalks Sub-committee

2.1.Kevin: We should re-write the circulation element of the community Plan and he will help do it.

2.2. Paula: PB Counts is Saturday and please come help out

2.3.Don Gross: Complained about run-on sentence on SSS Monitor, Gave Chris Council Policy on Neighborhood infrastructure needs and priorities, gave information about roundabouts

2.4.Ed: Hedges on Grand cause and obstruction of on coming cars, There is problem with storage of vehicles on the street-consider residential parking permits, there should be a bike path designation of IIA.

- 3. Motion Paula/second Chris: approval of previous minutes, Approval of agenda. Passed 4-0-0 Note: We will attempt to include all items on the approved agenda but items not covered during the scheduled meeting time will be heard at a subsequent meeting.
- 4. 5:10 Follow-up on items discussed at last meeting
 - 4.1. Meeting, date, time, location. Should we change it? This was discussed and nobody expressed an interest to change anything
 - 4.2. Use of <u>Panda@sandiego.gov</u> to report problems. Don Gross suggested to use this for reporting problems. Response from City Staff responded that Get it done is the primary method but if there is a problem with get it done you can report the problem to Panda. Don said it is best just to call the city departments
 - 4.3. Foothill Blvd/Loring St. Traffic Circle:
 - 4.3.1. PBPG approved Letter and sent to City. Response from City Staff is awaited. Don said the city will have to send this out to contractor because the city cannot do it. It was agreed we will request the procedure for this process from now until completion. Chris made this request on 8/17/2017 to Oscar Cortes.
- 4.4. Foothill Corridor traffic calming: update on neighborhood coordinating action.
 4.4.1. Chris gave a general update on this project and the reality is that the City is not likely to pursue this unless there is demonstrated support from the local community and especially the property owners most effected. Chris has offered to help residents create the wording for a petition so we are sure we accomplish what we are trying to do.
- 4.4.2. Ronni Ames stated that there are some residents on Vickie drive that do not like the idea of a roundabout at Vickie and Foothill because they don't want to "turn right before they turn left to get around the roundabout. Apparently, there are differing views on this and there might be a need for people to get a clear understanding of what this means.

- 4.4.3. Don Gross presented photos of roundabout that demonstrate what can be done including many examples alternative methods to do roundabout. The pictures are attached to the minutes. The examples are at Via Capri and Senn Way, also Stream View and Winn. Don said there is a city staff person named Russ that should be working on these roundabouts.
