### Progress on FY2025 Priorities

- D1 Council Member LaCava has now submitted 2 budget priority letters for FY 2025: Sep 27, 2023 and Jan 12, 2024.
- Both letters included ALL of the projects reviewed on Sep 20.
- Both letters divided the projects into either "annual workplans" or CIP categories.
- In addition, a new project appeared on the latest D1 list that was not in the previous letter, but was in the D2 list:
  - Bike and pedestrian path over I-5 from Balboa Transit Center.

- Projects can go on to the CIP list at any time with PG support.
- PG agenda used to keep track of existing CIP items and city updates.
  - CIP Projects will have a public summary available on the website
- A meeting where votes are cast by members of the community will be held annually in September to align with the City budget timeline



### Stop sign requests

- More stop signs on Bayard St. going from Loring St. to Garnet Ave.
- Four-way stop at Missouri St. and Haines St. within a block of PB middle school
- Four-way stop at Missouri St. and Haines St. This is adjacent to Diamond St. Vehicles speed coming west from Ingraham St., which leads to increased traffic volume. It is adjacent to PB middle school with a high volume of students on bikes, walking and fast e-bikes.
- Four-way, stop, sign or roundabout on Kendall and Beryl St. intersection
- Four-way stop signs on Beryl St and Kendall St.
- Four-way stop signs on Beryl St and Kendall St.
- Make all limit lines uniform at every stop sign. Some are with the stop sign, some behind it, some in front. Bring all to the same standard and paint the lines regularly.

### Feedback received on this year's process from PG members

#### What went well

- The community input was great.
- The July / August / September pacing.
- The graphics & posters were very important
- Scrubbing the list at our PBPG meeting was critical to the success of the meeting.
- Separating the projects into categories added some complication but was key to getting clarity & ensuring projects are considered to their "peer" project's.
- Assigning a project to each PBPG member
- Partnering with PBTC.

#### What could be improved

- Dot distribution took too long.
- Some community members did not engage in the process; they just turned up and voted for one project.
- Decision should be made by PG, not the public.
- Give the public just one vote per person
- Put voting instructions on screen during voting.
- Explain PG restrictions on discussions outside of meetings.
- Number the posters to match handouts.

### Observations on the process

- The process to gather possible projects was cumbersome.
- There was not enough time in one PG meeting to debate all the projects thoroughly
- There is little institutional memory within PG of projects or their fate
- There is low awareness of and integration with the city's process
- PG ownership or sponsorship of projects was not always clear
- Costs to produce posters exceeded the budget
- Material costs add up
- Printing costs were cheapest at North Side Printery (TC discount)
- Results slides were illegible at the meeting

#### RE: PB Planning Group Budget Priorities List for 2023

This letter responds to your request for a list of priorities for inclusion in your 2023 Budget Priority Memorandum. The list below contains items that were voted upon at the Planning Group's meeting on September 14, 2022. Items are listed in our order of priority.

- 1. Traffic Safety Measures:
  - a. Roundabouts at the following locations (in order of priority):
  - \* Foothill at Loring (already approved but needs funding)
  - \* Foothill at Vickie
  - \* Foothill at Tourmaline
  - \* Foothill at Opal

\* Crown Point Drive at Lamont & at La Cima & at Moreland

- 2. <u>Install Sidewalks Near Interstate 5 Entry</u>: Design and install sidewalks on the south side of Bluffside Drive and along southbound Mission Bay Drive starting at Bluffside Drive.
- 3. Intersection Improvements:
  - a. Continental Crosswalks (with Countdown Timer where appropriate):
    \* Garne Haines, Ingraham, and Jewell; at Kendall; at Lamont; at Morrell, at Noyes, at Soledad Mt. Road, and at Pendleton.

Pedestrian Beacons:

- \* Soledad Mt. Road at Los Altos (near Sessions Park).
- ✓ Ingraham at Fortuna
- \* As an alternative to above continental crosswalks, beacons on Garnet at Kendall, at Morrell, and at Noyes.
- 4. <u>Street Light Improvements</u>: Rose Creek path; Hornblend from Mission Boulevard to Ingraham; and Felspar from Mission Boulevard to Ingraham. Install energy efficient, low pollution lights onto existing lightpoles that cannot be repaired (i.e., reuse the existing poles)

- 5. Garnet Sidewalk Repairs and Improvements: Entire length on both sides.
- Complete PB Pathways Phase 3: Complete connection at Olney Street to Campland entrance. Complete at Cass between Tourmaline and PB Drive, and at Diamond, Fanuel and Reed Streets.
  - PB Entrance Signs: At Westbound Balboa Avenue, at the Ingraham Street Bridge; Southbound La Jolla Boulevard; and at Northbound Mission Boulevard after the Interstate 5 offramp.
- 8. <u>Community Bike Racks</u>: At multiple locations on business district streets of Garnet, Cass and Grand
- 9. <u>Placemaking</u>: Around schools and parks, including benches, murals, artwork, signage, etc.
  - 10. <u>One Way Street Evaluation</u>: For Crown Point Drive between Pacific Beach Drive and Lamont Street.



- September 24:
  - Draft final letter sent to Marcella for signature.

- Install roundabout at Foothill Blvd. and Loring St.

- Repair the sea wall between south Mission Beach and Crystal Pier.
- Repave Mission Blvd. from Loring St. to Chalcedony St.
- Repave Soledad Rd. north of Loring St.




FY 2024-28 CIP Outlook by Funding Source
