## Non Agenda Public Comment:

Leigh Gibson – ALRC report is good and thorough, but need to include high number of visitors in our community when looking at crime statistics – 860,000 visitors over Memorial Day, DUIs down from last year. Marcie Beckett – Handout "Timeline of Alcohol License Issues and Developments in Pacific Beach" with supporting newspaper articles. From 2003 to present: police protesting new licenses; PBTC supporting new licenses for restaurants but not bars; district 2 candidates saying alcohol is PB's most serious issue; Beach Alcohol Task Force; police chief blocking new licenses then reversing decision; ABC saying no new licenses for PB; police recommending applicants go to PBTC for community support; PBPG forms ALRC to review license applications; ALRC completes research and presents findings to community.
